BY-LAW No. 2

A By-Law amending By-law Number One (1) of the Corporation to alter the terms and qualifications of directors on the board of directors.

Whereas Niagara North Vacant Land Condominium Corporation No. 214, (the "Corporation"), is a duly incorporated condominium of Ontario, pursuant to the *Condominium Act,* 1998, S.O. 1998, c. 19, and any amendments thereto, (the "Act"), by virtue of the registration of a Declaration on November 5, 2010, and bearing Instrument No. NR254646;

And Whereas By-Law No. 1, registered as Instrument No. NR255177 on November 12, 2010, within the Town of Niagara-on-the-Lake, in the Regional Municipality of Niagara, Land Registry Office (No. 30), contains provisions with respect to the Corporation's Board of Directors;

And Whereas a Corporation may make, amend or repeal by-laws with respect to the number, terms, and qualifications of directors pursuant to section 56(1)(a) of the Act;

Therefore Be It Resolved that the Board of Directors, has moved by majority, that By-law No. 1 for Niagara North Vacant Land Condominium Corporation No. 214 be amended as follows:

1. Article VI of By-law No. 1 be amended to include a new section, namely paragraph 3(c), which shall include:

"Article VI(3)(c):

Directors serving two consecutive 3-year terms shall not be eligible for re- election unless 2-years have passed since serving such two consecutive terms."

2. The remaining provisions within By-law No. 1 shall remain in full force and effect.
